## Stallion Service Contract: *Westporte* Fresh-Cooled Semen

This contract is made between **Darlene York** of Country Lane Farm (*Stallion Owner*), and

\_\_\_\_\_ (*Mare Owner/Lessee*), for the breeding of

\_\_\_\_\_ (*Mare*), to **Westporte** (*Stallion*) for the

current breeding season only and subject to the following terms and conditions:

1. All fees must be paid prior to shipment of semen and are subject to 5% GST for Canadian residents.
2. The Stallion Service refers to Fresh-Cooled Semen provided for insemination purposes. Please refer to the correct handling procedures and timelines for viability of the semen. It is the Mare Owner/ Lessee responsibility to ensure correct handling after shipment has been received. The Stallion Owner agrees to provide viable semen.
3. Both parties agree the semen is provided for the Mare described in the contract only. Confirmation of insemination and conception of Mare must be received by Stallion Owner before a signed breeding certificate will be released to Mare Owner/Lessee for offspring registration. Embryo transplants are prohibited without prior written permission from Stallion Owner. The Mare Owner/Lessee is not permitted to resell the semen.
4. All fees incurred by Mare Owner/Lessee for the breeding of the Mare are the responsibility of the Mare Owner/Lessee, including semen-related expenses, shipping expenses, as well as Mare or foal expenses incurred. Mare Owner/Lessee must provide a FedEx number for shipment OR a credit card for shipping costs.
5. **Semen collection days for the Stallion are Monday, Wednesday, and Friday. All semen orders must be received prior to 11:00am (Pacific Standard Time) the 24 hours to breeding your mare.** Late requests will be honored only if collection is possible.
6. The current breeding season extends from April 15 through July 15.
7. Mare Owner/Lessee warrants that Mare is in sound breeding condition. Mare Owner/Lessee agrees that Mare will be bred by a licensed veterinarian with considerable

experience in artificial insemination and access to an ultrasound machine. This contract shall be null and void and Mare Owner/Lessee shall be entitled to one dose of frozen semen if the Stallion should die or become unfit to breed.

8. Seller shall not be responsible for lost semen shipments or delays in delivery not within the control of the Seller such as missed flights, weather delays, failure of third-party service.
9. Should the Mare fail to be in foal, the full fee is due and payable prior to another shipment. If the Stallion is unable to collect fresh semen, one dose of frozen semen will be supplied excluding dry-shipper rental storage and retrieval fee.
10. Live Foal Guarantee: A live foal is defined as a foal that stands and attempts to nurse. The live foal guarantee is valid until the end of the following year's breeding season.
11. The laws of the Province of British Columbia, Canada shall govern the terms of this agreement.
