Stallion Service Contract: Westporte Frozen Semen

This contract is made between Darlene York of Country	y Lane	Farr	n (Stallion C	Owner), ar	ıd

current breeding season only and subject to the following	ina terr	ms c	and conditio	ons:		

- 1. This contract covers the purchase of a single frozen semen dose and/or multiple single doses. The one dose will contain the correct amount of straws required for one insemination. The number of straws is determined after each collection. The number of straws required is provided to you when your frozen semen is shipped to you.
- 2. All sales are subject to availability and are final upon acceptance of this Agreement. All fees are payable upon execution of this Agreement. Buyer specifically agrees and understands that no semen will be shipped until all fees have been paid.
- 3. There is no live foal guarantee.
- 4. Upon execution of this sales agreement and receipt of all fees the frozen semen becomes the property of the Buyer. Buyer agrees to pay storage fees associated with the frozen semen to the storage facility if delivery of frozen semen is not taken within five business days or otherwise agreed upon.
- 5. Buyer is responsible for compliance with registry requirements for the use of frozen semen and payment of any fees for the subsequent registration of foals conceived.
- 6. The splitting of doses or straws is strictly forbidden.
- 7. The price paid for this contract per dose is for a single pregnancy or embryo, per dose.
- 8. The full price of each dose is required for any extra embryos recovered or transferred, should the buyer breed via embryo transfer or ICSI.
- 9. Breeder agrees to submit to Stallion owner confirmation of the Mare's pregnancy at 14-16 days post-ovulation and 55-60 days post-ovulation. Stallion Agent recommends an additional pregnancy check at 30-35 days post-ovulation to confirm presence of a viable single embryo.

- 10. Stallion Agent will issue a single registry breeding certificate pre dose, a breeding certificate providing receipt of written notification signed by the attending veterinarian detailing dates of insemination and pregnancy examinations, pregnancy status as well as identification of the mare that was bred. Breeder must submit all insemination and pregnancy report.
- 11. The Buyer shall assume all responsibility for the condition and management of the mare and will bear all risk of loss or damage to the mare whether by death, disease, injury, infection or otherwise, and by any cause whatsoever and therefore agrees to hold Seller or any person employed or associated with Country Lane Farm harmless for any and all damages associated therewith.
- 12. Buyer is responsible for all shipping, tank rental and handling fees associated with delivery of the semen from the storage facility and return of the shipping container.
- 13. Once the shipment arrives it should be inspected immediately. Any claims regarding the integrity of the shipment must be filed within 24hrs of delivery.
- 14. Seller shall not be responsible for lost semen shipments or delays in delivery not within the control of the Seller such as missed flights, weather delays, failure of third-party service.
- 15. The frozen semen is not insured during shipment. Insurance for the value of the semen can be purchased through FedEx. Buyer is responsible for additional insurance fees.
- 16. This Contract may not be transferred. If the mare is sold or unfit for breeding, contact Country Lane Farm.
